## Supervisors Order Tube Fire Escape Installed At County Home Committee Reports Completion of New Wards Place One of Best

Emmet County wants her poor protected from fire hazard and today the county board of supervisors through its committee in charge of the county home on Charlevoix Avenue in this city, directed that a new tubular fire escape be installed at the home. With the installation of this outfit, which is one of the same modern type for patients as is now in use at Petoskey hospital, the sick and aged occupying rooms on the upper floor of the structure can be quickly chuted down the tube and out of doors in case of fire in the wooden structure.

In addition to the new escape the county has just completed a new elevator in the building, making it easier to handle the sick and crippled. Two new wards are just being completed giving Emmet County one of the finest homes for the poor and aged in the region.

The home is on the high bluff overlooking Little Traverse Bay and only a few hundred feet from the water's edge. Just across Charlevoix Avenue is the county fair grounds and the patients at the home are taken across each day to the fair doings in the early autumn. They also manage to see the baseball games, horse and car races held there and circuses and other events.

Present at today's meeting arranging for the improvements were Supervisors Frank Ward, Readmond: Carl Kuebler, Brutus; William Foster, Carp Lake; Alex Lark, Center; and John Quinlan, Petoskey. The cost of the new fire escape is \$890 and it was purchased through the McCabe Hardware.

At the same meeting of the committee, the firm of Lloyd Thomas, appraised engineers, was contracted with to make an immediate appraisal of all property owned by the county and controlled by the supervisors. The board wishes this for use in determining the amount of insurance, etc. The coal contract with John Nyman was renewed for the year.

Harvey Fredrickson was secured as caretaker for the fair grounds and a contract with the Northern Michigan Protective agency for county property also was signed by the committee.


